## **I. Controlling and processing of the personal data of website users and applicants:**

At MedRes Kft, the protection of personal data is of high importance. Our Company performs the processing of personal data on the basis of the **General Data Protection Regulation (GDPR) and the Act CXII of 2011 on Informational Self-determination and the Freedom of Information (Information Act)**. ### **1. Direct contact**

Please be informed that for the purpose of direct contact in connection with the filling in of the on-line contact form on the website medres.hu MedRes Kft. stores and processes your personal data as follows:

Name, address, phone number, e-mail address, department and position, address, other not requested identification data provided by you;

We received the aforesaid data from you, your company or from public information sources, e.g. company registry, website, etc.

Our Company will store and use your personal data you enter into the contact forms for the purpose you requested especially for example for contacting you individually, initiating or concluding a contract and deliver all information you need. This will only happen after you have agreed to your data being stored and processed, indicated by accepting the appropriate checkbox provided with the contact form. Your data shall be stored therefore **per your consent**, until the either you withdraw your consent or the purpose of the handling of the personal data is fulfilled for example you are provided by the requested information.

Your data shall be handled by our following employees: managing director; persons concerned with answering your question, contact and data protection; data protection officer.

## 2. Browsing our Website – Cookies and Cookie Policy

Our website may use cookies. These are small text files stored by the browser of your device. The cookies have no damaging consequence. The purpose of using cookies is to make our website more user-friendly.

The cookies used by our website:

- functional cookies

The functional cookies ensure that the website works and therefore the functional cookies cannot be switched off in our system.

- performance cookies

The performance cookies or statistic cookies optimize the website performance. These cookies increase the speed of the website thus we save you time during browsing our website. The performance cookies are placed by third party (Google Analytics). The Google Analytics 4 used by the website does not store IP data and the stored data will be collected within the EU. The collected data will be transferred afterwards to the servers of Google outside EU territory (USA), therefore there is no direct connection between the data controller and the American servers of Google.

You can switch off the performance cookies on the website any time, thus you can withdraw your consent to controlling your personal data. Alternatively, you can install the deactivation add-on for Google Analytics (<https://tools.google.com/dlpage/gaoptout?hl=en>), so long as it is available for your browser.

The website uses “Persistent cookies”, which remain on your computer as long as you does not delete them. These allow us to recognise your computer the next time you visit our site. You can set the expiration date of these cookies in your browser, after their expiration these will be deleted by default. They can be deleted any time by you manually as well.

Furthermore the website uses “Session cookies” which are different in so far as they are automatically deleted from your hard drive at the end of your browser session.

If placing cookies are not permitted by you, please note that it may restrict the options available and the convenience of our website.

## II. General rights of the data subjects

According to the law you have right to be provided with **information** regarding your stored and controlled date and may exercise the following rights: **right of access** (Article 15 of the GDPR, information about ongoing data processing and its details, data categories, legal basis, storage time, source of data etc.), **right to rectification** (Article 16 of the GDPR, rectification of false or incorrect data), **right to erasure** (right to be forgotten – Article 17 of the GDPR, e.g. in case of withdrawal of consent), **right to restriction of processing** (Article 18 of the GDPR, e.g. restriction of processing of false or incorrect

data until it is corrected or restricted processing of such data requested by data subject which should have been deleted otherwise), **right to data portability** (Article 20 of the GDPR), **right to withdraw consent** (Article 7 (2) of the GDPR), **right to object** (Article 21 of the GDPR).

In the event of a potential data protection incident, you may request information about the circumstances, effects, and measures taken to prevent the incident. If the incident is likely to pose a high risk to your rights and freedoms, the Controller will inform you without undue delay in the manner specified on Art 34 of the GDPR.

You can withdraw your consent to the processing of your personal data at any time by contacting the Controller, however, the withdrawal of consent does not affect the legality of the data processing before the withdrawal.

If you believe that the processing of your data violates the data protection regulation or your data protection rights have been breached, you may file a claim to the supervisory authority (right to lodge a complaint with the supervisory authority - Article 77 of the GDPR), and you may enforce your rights before a competent court for compensations and damages according to law.
